having for the last six months or more carried on the trade or calling of
Secretary of a Registered Club HEREBY GIVE YOU NOTICE that it is my
intention to apply to the Licensing Justices for the City of Manchester
sitting at the Transfer Sessions to be held at the Magistrates Court Crown
Square Manchester M60 1PR on Thursday the 29th day of May 1980 at 10.30
o'clock in the forenoon for the provisional grant to me of a Justices On
Licence in respect of the premises known as the "New Reno Club" situate
in the basement of the building numbered 1a Princess Road/208 Moss Lane
East Manchester M14 4TE authorising me to sell by retail intoxicating liquor
of all descriptions for consumption only "ON" the premises situate and
known as aforesaid. The said building is owned by Victor Sereno of
22 Lulworth Road Southport Merseyside PR8 2BQ.

AND I FURTHER GIVE YOU NOTICE that if such Provisional Justices On Licence
is granted as aforesaid it is my intention to request the said Licensing
Justices to impose the following conditions upon such Licence :-

1. No intoxicating liquor shall be supplied otherwise than to
 - (a) a member of the said Club who has been a member for at least two days or whose nomination or application for membership was made at least two days before his admission.
 - (b) a guest of such a member bona fide entertained by him at his own expense.
2. No intoxicating liquor shall be supplied for consumption "OFF" the premises.
3. There shall be Rules of the Club for the election of members and a copy of such Rules and any other Rules shall be deposited with the Clerk to the Licensing Justices. Notice of any alteration in any of the Rules shall be given to the Clerk to the Licensing Justices within fourteen days.
4. A list of the names and addresses of all members of the said Club shall be kept on the premises (and produced on demand for inspection by a Constable).
5. No alteration shall be made in the Rules providing for the admission of persons without the consent of the Licensing Justices.
6. No application shall be made under the authority of the Licence for the grant of consent to an Occasional Licence.

In accordance with Mr. Magbotiwan's recent instructions, we have applied for a Provisional Justices On Licence with Club Conditions in your name and the programme of events is as follows :-

1. Application has been served on the Court, the Police, the Fire Department and the Local Authority.
2. Between now and the actual hearing members of the Fire Service, the Health Department, the City Architects Department and the Police will inspect the premises and their requirements (if any) will be made known to you.
3. Notice of your application will appear in the Manchester Evening News on Friday the 9th May 1980 under Legal Notices.
4. Notice of your application must be advertised on the premises and we enclose herewith a Notice which should be Affixed to the outside of the Club premises in such a position that it cannot be damaged by vandals or weather. We enclose an additional Notice just in case of any accidents. The Notice must remain in that position until the date of the actual hearing. Please put the Notice up on Friday the 9th May 1980.
5. On receipt of this letter please contact immediately the Liquor Licensing Department of Greater Manchester Police, Chief Inspector Mottram or Sergeant Hurst (Tel. No. 061 855 3171) and arrange to be interviewed for the purpose of your application. Please do not delay doing this.
6. The Licensing Justices will visit the premises sometime on the morning of Thursday the 15th May 1980 accompanied by the Police and representatives of the Fire Department and the Local Authority and the writer will be in attendance. We will let you know the approximate time nearer the day.

7. Your application will come for hearing before the Licensing Planning Committee on Thursday the 22nd May 1980 at 10.15 a.m. in Court number 7 on the fifth floor of the Magistrates Court, Crown Square, Manchester 3. You will be required to give evidence and you should meet the writer in the corridor outside the above numbered Court no later than 10 a.m. If that Committee have no objection then :-

8. Your application will come for hearing on Thursday the 29th May 1980 at 10.30 a.m. in the same Court as above. Again you should meet the writer in the corridor outside the above numbered Court no later than 10.15 a.m

Please note that because there is an existing Registered Club the application is in two sections.

First we have to get the new Licence and if this is successful then the existing Club will continue to operate until the end of permitted hours on the 30th July 1980 and on the 31st July 1980 we will then apply for the Final Order, new Music and Dancing Licence and new Special Hours Certificate. It is from that date the new Club will operate on the premises.

Please also note that as a result of the change in the licensing position the Club will not be able to use its "fruit machines" after the 30th July next and will only be able to have a maximum of two amusement machines with prizes (maximum payout £1.00).

The Proprietorship Licence will not help in the variation of the hours of the Club which remain at 12.30p.m. to 3 p.m. and 6.30p.m. to 2 a.m. Mondays to Saturdays inclusive. Please bear this in mind.

We have also lodged Rules with the Court and the Police and we enclose a copy for you to read and thoroughly digest.

Would you please acknowledge this letter and in particular deal with paragraph numbered 5 above without delay and in due course number 4,
